Overview

The management of the crowded space is perceived as a complex activity, however, much of the theory and practice is based on simple concepts. 

Scientific Notions of Crowd Management



Overview

The key concepts of managing crowded space are underpinned by scientific and mathematical theory linked to psychology, human interaction and human spatial mapping. The laws of physics, such as Newton's First and Second Law's, explain the movement of crowds, the forces exerted on, as well as by them, and how the dynamics of crowds can change. Simple mathematical principles are also used to ascertain flow rates, ingress, egress and circulation.

This course provides an integrated approach, where the scientific theories mentioned above are combined with social constructs including proxemics, topophobia and topophilia, theories of play and human spatial mapping as well as sociology and psychology giving you a holistic understanding of the key principles and concepts at work in the crowded space.

- Understand the need for knowledge of scientific notions related to crowds
- Determine why the scientific theory of crowds has to be applied in context
- Comprehend what aspects of theory can be attributed to certain kinds of activity within the crowd





Planning for an Event and Tactical Options



Overview
